Joe,

This is a DNR requirement, not a Town of Worcester delay tactic. I am copying in Robin Miller so you can take your concerns directly to her. I had requested in several town meetings exactly the information that she is requesting, and did not get anything. Since I was not successful in convincing anybody to do this, I am asking you because I know that you have influence. This is a case where cooperation will get results.

If I had received this information, I would have sent it directly to her. As discussed in the DNR Guidelines document, there are procedures to be followed in order to pass boating ordinances. If we follow the procedures, we can get this ordinance passed. Please note that we had extensive contact with the DNR on the Disappearing Creek bridge project. Also with the town sand/salt storage. We followed their procedures, and everything moved forward.

BTW, I would have replied earlier, but other town business came first. Today: Legal issue in the 25 acres, investigate a road complaint, DNR sand/salt storage inspection (we passed), road crew to list surplus equipment, town equipment storage, prioritized list of roads for spring road inspection for crack sealing, road crew issues. And more to do tomorrow. Jim

In order to meet the necessary items listed on page 7 of the guidelines document, we need additional statements. I am copying several people who have that information. I have also copied two people in a position to summarize the arguments against this proposed ordinance.

Everybody, Robin made it clear in our conversation that these written statements are necessary to get DNR approval of this proposed ordinance. From the guidelines document:

The condition report should include, at a minimum, the following items:

- A description of the local conditions necessitating the regulation or regulation change and how the new or changed local regulation will solve the situation.
- A description of the probable or possible negative effects of the measures that were considered, and people or groups who may be adversely affected by the adopted ordinance.
- An opinion statement concerning the impact on public health, safety, or welfare if the regulation is not adopted.
- A statement summarizing the arguments of the interests opposed to the regulation or regulation change.


